THE ACCOUNTANT REVIEWS THE INVOICES AND MUST APPROVE THEM FOR PAYMENT BEFORE THE CHIEF EXECUTIVE OFFICER ORDERS PAYMENT ELECTRONICALLY. EACH WEEK THE ACCOUNTANT AND THE EXECUTIVE TEAM REVIEW CONTRACT BILLING AND RESTRICTED FUND RELEASES AS A FINAL CHECK THAT THE USE OF THE FUNDS HAS BEEN IN ACCORD WITH FUNDER REQUIREMENTS AND THAT STONE HOUSE FINANCIAL RECORDS ACCURATELY REFLECT THE FLOW OF FUNDS.
